The BNB intends to engage the Consultancy Firms registered with Pakistan Engineering Council for the above titled development project having approved cost of Rs:178.000 million including Rs: 146.000 million for Civil Work.

Proposals for Engineering / Architectural Consultancy Services are invited for Sub-Soil Testing, Planning, Designing, Engineer's Estimate including Tender Documents and Top Construction Supervision of Civil work of the project. The consultancy will cover the following tasks:

Interested Consultancy Firms are requested to download RFP documents having detailed Terms of References (TORs) along with evaluation criteria from SPPRA website i.e. https://portalsindh.eprocure.gov.pk or University website: www.bnbwu.edu.pk or Project Directorate BNBWU office on any working day except the day of opening of tenders from 17-09-2025 to 31-10-2025 on payment of Rs: 5000/- (Non-refundable in shape of call deposit / DD in favour of "The Begum Nusrat Bhutto Women University". Proposals will be evaluated by using Single Stage - Two Envelope Procedure: Quality & Cost based selection method (QCBS) with Quality (70%) plus Cost (30%). Interested firms shall be required to submit their Technical and Financial Proposals in separate sealed envelopes clearly marked "Technical Proposal" & "Financial Proposal' in bold and legible letters to avoid confusion. Both these Proposals shall be enclosed in an outer envelope and shall be submitted as a single package through registered mail or by hand in office of the Project Director BNBWU Sukkur on 03-11-2025 before 11:30 p.m and same shall be opened at the same location and on same day at 12:00 p.m by the Consultant Selection Committee in the presence of bidders or their authorized representative who wish to be present. Initially, only the envelope marked "Technical Proposal" shall be opened. "Financial Proposal" of only technically qualified bidders shall be opened. In case of public Holiday or in case any member of Consultant Selection Committee is not available the proposal will be submitted and opened on next working day at same location and time. In-complete and late proposals will not be entertained. Earnest money at a rate of 2% of bid value in the shape of call deposit / DD prepared from the scheduled Bank in favour of "The Begum Nusrat Bhutto Women University, Sukkur" must accompany with Financial Proposal.
